A BILL FOR AN ACT

101 **CONCERNING THE COLORADO CHILDREN'S TRUST FUND.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill clarifies that Colorado children's trust fund moneys must be used for prevention, rather than intervention, programs, and extends its repeal to July 1, 2022.

1 **SECTION 1.** In Colorado Revised Statutes, 19-3.5-102, **amend**
2 (2) as follows:

3 **19-3.5-102. Legislative declaration.** (2) It is the purpose of this
4 article to promote PRIMARY AND SECONDARY prevention and education
5 programs that are designed to lessen the occurrence ~~and reoccurrence~~ of
6 child abuse and neglect and to reduce the need for state intervention in
7 child abuse and neglect prevention and education.

8 **SECTION 2.** In Colorado Revised Statutes, 19-3.5-105, **amend**
9 (1) (a) and (1) (f) as follows:

10 **19-3.5-105. Powers and duties of the board.** (1) The board shall
11 have the following powers and duties:

12 (a) To provide for the coordination and exchange of information
13 on the establishment and maintenance of PRIMARY AND SECONDARY
14 prevention programs;

15 (f) To expend moneys of the trust fund for the establishment,
16 promotion, and maintenance of PRIMARY AND SECONDARY prevention
17 programs, including pilot programs, for programs to prevent and reduce
18 the occurrence of prenatal drug exposure, and for operational expenses of
19 the board;

20 **SECTION 3.** In Colorado Revised Statutes, 19-3.5-107, **amend**
21 (1) as follows:

22 **19-3.5-107. Disbursement of grants from the trust fund.**

23 (1) Grants may be awarded to provide moneys for the start-up,
24 continuance, or expansion of PRIMARY OR SECONDARY prevention
25 programs, including pilot programs and home visitation programs, to
26 provide educational and public informational seminars, and to study and
27 evaluate PRIMARY AND SECONDARY prevention programs, pilot programs,

1 and home visitation programs. In addition, grants may be awarded for
2 programs to prevent and reduce the occurrence of prenatal drug exposure.

3 **SECTION 4.** In Colorado Revised Statutes, **amend** 19-3.5-109
4 as follows:

5 **19-3.5-109. Report - repeal of article.** (1) The department of
6 public health and environment shall contract for an independent
7 evaluation of the trust fund including administrative costs of operating the
8 trust fund and the cost-effectiveness and the impact of the grants on
9 reducing and preventing child abuse. A report of such evaluation shall be
10 provided to the house and senate health and human services committees,
11 or any successor committees, by November 1, 2011, AND BY NOVEMBER
12 1, 2021.

13 (2) This article is repealed, effective July 1, ~~2012~~ 2022.

14 **SECTION 5. Safety clause.** The general assembly hereby finds,
15 determines, and declares that this act is necessary for the immediate
16 preservation of the public peace, health, and safety.
