Effective Date: The bill was signed into law by the Governor on March 16, 2012, and takes effect August 8, 2012, assuming no referendum petition is filed.

Summary of Legislation

Current law allows individuals who are not licensed by the state to inspect drivers' license and motor vehicle registration information, but only for specific purposes. This bill streamlines access of drivers' license and motor vehicle registration information for licensed private investigators, licensed private investigative agencies, and licensed security services.

Background

Colorado law does not require the licensing of private investigative agencies or security services. House Bill 11-1195, which was signed into law on June 10, 2011, established a voluntary licensure program for private investigators. Under the bill, beginning July 1, 2012, only individuals who meet certain requirements and have been issued a voluntary state license may use the term "licensed private investigator." The licensing program is repealed, effective July 1, 2016, following a sunset review.

State Revenue

The bill is expected to increase revenue from fees to the Department of Regulatory Agencies (DORA) in FY 2012-13. Fees for licensure are credited to the Division of Registration Cash Fund at the DORA; fees for fingerprint-based criminal history background checks are credited to the Identification Unit Cash Fund in the Department of Public Safety (DPS).

License fee impact on private investigators. While fees for licensure are expected to increase as more private investigators become licensed in order to gain streamlined access to drivers' license and motor vehicle registration information, the exact increase in revenue was not known at the time this fiscal note was written. The note will be updated to reflect this information when it becomes available.

Criminal history check fee impact. While the fiscal note assumes that there will be an increase in fingerprint-based criminal history background checks conducted by the DPS as more private investigators become licensed, the exact increase was not known at the time this fiscal note was written. The note will be updated to reflect this information when it becomes available. The DPS charges a fee of \$39.50 per applicant.

State Expenditures

The Department of Revenue (DOR) currently allows individuals who are not licensed by the state to inspect drivers' license and motor vehicle registration information. While the bill will require the DOR to update department rules, forms, manuals, and websites, the increase in department workload is minimal and will not require an adjustment in appropriations for any state agency.
