HOUSE BILL 26-1405

BY REPRESENTATIVE(S) Brown and Sirota, Taggart, Duran;
also SENATOR(S) Amabile and Kirkmeyer, Bridges.

CONCERNING TRANSFERS OF MONEY FROM CERTAIN CASH FUNDS TO THE
GENERAL FUND.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, 8-15.7-305, **add** (3.7)
as follows:

**8-15.7-305. Scale-up grant fund - creation - gifts, grants, or
donations - transfer.**

(3.7) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER
ONE MILLION FIFTY-SEVEN THOUSAND ONE DOLLARS FROM THE FUND TO THE
GENERAL FUND.

SECTION 2. In Colorado Revised Statutes, 8-15.7-405, **add** (3.7)
as follows:

8-15.7-405. Qualified apprenticeship intermediary grant fund

- creation - transfer - gifts, grants, or donations.

(3.7) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER SEVEN HUNDRED NINETY-SIX THOUSAND NINE HUNDRED FIFTY-NINE DOLLARS FROM THE FUND TO THE GENERAL FUND.

SECTION 3. In Colorado Revised Statutes, 8-44-206, **add (3)(b)(III)** as follows:

8-44-206. Guaranty fund - immediate payment fund - legislative declaration - repeal.

(3) Immediate payment fund - assessments - creation of fund.

(b)(III)(A) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER TWO HUNDRED THOUSAND DOLLARS FROM THE IMMEDIATE PAYMENT FUND TO THE GENERAL FUND.

(B) THIS SUBSECTION (3)(b)(III) IS REPEALED, EFFECTIVE JULY 1, 2027.

SECTION 4. In Colorado Revised Statutes, 8-67-105, **add (4)** as follows:

8-67-105. Colorado uninsured employer fund - repeal.

(4)(a) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (2)(e) OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER FIVE HUNDRED THOUSAND DOLLARS FROM THE FUND TO THE GENERAL FUND.

(b) THIS SUBSECTION (4) IS REPEALED, EFFECTIVE JULY 1, 2027.

SECTION 5. In Colorado Revised Statutes, 19-1-307, **add (2.5)(c)** as follows:

19-1-307. Dependency and neglect records and information - access - fee - records and reports fund - misuse of information - penalty - adult protective services data system check - rules - repeal.

(2.5) Fee - records and reports fund - rules.

(c) (I) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER SEVEN HUNDRED FIFTY THOUSAND DOLLARS FROM THE RECORDS AND REPORTS FUND TO THE GENERAL FUND.

(II) THIS SUBSECTION (2.5)(c) IS REPEALED, EFFECTIVE JULY 1, 2027.

SECTION 6. In Colorado Revised Statutes, 23-3.1-306.5, **add** (10) as follows:

23-3.1-306.5. College kickstarter account program - funding - administration - financial literacy course - rules - legislative declaration - definitions - repeal.

(10)(a) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2026, OF MONEY CREDITED TO THE KICKSTARTER PROGRAM MASTER ACCOUNT OTHER THAN MONEY DESIGNATED FOR AN ELIGIBLE CHILD, THE STATE TREASURER SHALL, IN CONSULTATION WITH THE AUTHORITY, TRANSFER NINE MILLION TWO HUNDRED THOUSAND DOLLARS TO THE GENERAL FUND.

(b) THIS SUBSECTION (10) IS REPEALED, EFFECTIVE JULY 1, 2027.

SECTION 7. In Colorado Revised Statutes, 24-21-404, **add** (4) as follows:

24-21-404. Electronic recording technology fund - electronic filing - grants - repeal.

(4)(a) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (1)(b) OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER TWO HUNDRED THOUSAND DOLLARS FROM THE FUND TO THE GENERAL FUND.

(b) THIS SUBSECTION (4) IS REPEALED, EFFECTIVE JULY 1, 2027.

SECTION 8. In Colorado Revised Statutes, 24-22-115, **add** (2)(h) as follows:

24-22-115. Tobacco litigation settlement cash fund - health-care supplemental appropriations and overexpenditures account - creation - repeal.

(2) (h) (I) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER TWO HUNDRED FIFTY THOUSAND DOLLARS FROM THE TOBACCO SETTLEMENT DEFENSE ACCOUNT WITHIN THE TOBACCO LITIGATION SETTLEMENT CASH FUND TO THE GENERAL FUND.

(II) THIS SUBSECTION (2)(h) IS REPEALED, EFFECTIVE JULY 1, 2027.

SECTION 9. In Colorado Revised Statutes, 24-32-728, **add** (10)(e) as follows:

24-32-728. Mobile home park resident empowerment loan program - fund - creation - policies - report - legislative declaration - definitions - repeal.

(10) (e) (I) ON JUNE 30, 2027, AND ON EACH JUNE 30 THEREAFTER THROUGH JUNE 30, 2033, THE STATE TREASURER SHALL TRANSFER FOUR HUNDRED THOUSAND DOLLARS FROM THE FUND TO THE GENERAL FUND.

(II) THIS SUBSECTION (10)(e) IS REPEALED, EFFECTIVE JULY 1, 2034.

SECTION 10. In Colorado Revised Statutes, 24-32-3501, **amend** (7)(e)(II); and **add** (7)(e)(I.5) as follows:

24-32-3501. Peace officers behavioral health support and community partnerships grant program - created - report - rules - fund - definitions - repeal.

(7) (e) (I.5) ON JULY 1, 2026, THE STATE TREASURER SHALL TRANSFER FOUR HUNDRED THOUSAND DOLLARS FROM THE FUND TO THE GENERAL FUND.

(II) This subsection (7)(e) is repealed, effective ~~July 1, 2026~~ JULY 1, 2027.

SECTION 11. In Colorado Revised Statutes, 24-32-3805, **amend**

(5) as follows:

24-32-3805. Child care facility development cash fund - definitions - repeal.

(5) (a) (I) ON JULY 1, 2026, THE STATE TREASURER SHALL TRANSFER ONE HUNDRED SEVENTEEN THOUSAND FIVE HUNDRED FIFTY-ONE DOLLARS FROM THE FUND TO THE GENERAL FUND.

(II) THIS SUBSECTION (5)(a) IS REPEALED, EFFECTIVE JULY 1, 2027.

(b) The state treasurer shall transfer all unexpended and unencumbered money in the fund on June 30, 2029, to the general fund.

SECTION 12. In Colorado Revised Statutes, **amend 24-33.5-426** as follows:

24-33.5-426. Colorado bureau of investigation identification unit fund - repeal.

(1) All ~~moneys~~ MONEY collected by the department for the purposes of fingerprint criminal history record checks and name criminal history record checks shall be transmitted to the state treasurer, who shall credit the same to the Colorado bureau of investigation identification unit fund, which fund is hereby created and referred to in this section as the "fund". In addition, the fund may consist of ~~moneys~~ MONEY that may be appropriated to the fund by the general assembly. The ~~moneys~~ MONEY in the fund shall be IS subject to annual appropriation by the general assembly for the direct and indirect costs associated with conducting criminal history record checks. Any ~~moneys~~ MONEY in the fund not expended for the purpose of criminal history record checks may be invested by the state treasurer as provided by law. All interest and income derived from the investment and deposit of moneys in the fund shall be credited to the fund. Any unexpended and unencumbered ~~moneys~~ MONEY remaining in the fund at the end of a fiscal year shall remain in the fund and shall not be credited or transferred to the general fund or another fund.

(2) (a) NOTWITHSTANDING SUBSECTION (1) OF THIS SECTION, ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER ONE MILLION DOLLARS FROM THE FUND TO THE GENERAL FUND.

(b) THIS SUBSECTION (2) IS REPEALED, EFFECTIVE JULY 1, 2027.

SECTION 13. In Colorado Revised Statutes, 24-33.5-527, add (4)(b)(II)(D) as follows:

24-33.5-527. Multidisciplinary crime prevention and crisis intervention grant program - committee - fund - reports - repeal.

(4) (b) (II) (D) NOTWITHSTANDING ANY PROVISION OF THIS SUBSECTION (4) TO THE CONTRARY, ON JULY 1, 2026, THE STATE TREASURER SHALL TRANSFER FOUR HUNDRED TWENTY-SEVENTHOUSAND ONE HUNDRED THIRTEEN DOLLARS FROM THE FUND TO THE GENERAL FUND.

SECTION 14. In Colorado Revised Statutes, 24-33.5-528, add (4)(e)(IV) as follows:

24-33.5-528. Law enforcement workforce recruitment, retention, and tuition grant program - committee - fund - reports - repeal.

(4)(e)(IV) NOTWITHSTANDING ANY PROVISION OF THIS SUBSECTION (4) TO THE CONTRARY, ON JULY 1, 2026, THE STATE TREASURER SHALL TRANSFER ONE HUNDRED ELEVEN THOUSAND ONE HUNDRED NINETY-ONE DOLLARS FROM THE FUND TO THE GENERAL FUND.

SECTION 15. In Colorado Revised Statutes, 24-33.5-529, amend (4)(e)(II); and add (4)(e)(1.5) as follows:

24-33.5-529. State's mission for assistance in recruiting and training (SMART) grant program - committee - fund - reports - definitions - repeal.

(4)(e)(I.5) NOTWITHSTANDING ANY PROVISION OF THIS SUBSECTION (4) TO THE CONTRARY, ON JULY 1, 2026, THE STATE TREASURER SHALL TRANSFER SIX HUNDRED EIGHTY-SIX THOUSAND EIGHT HUNDRED NINETY DOLLARS FROM THE FUND TO THE GENERAL FUND.

(II) This subsection (4)(e) is repealed, effective ~~July 1, 2026~~ JULY 1, 2027.

SECTION 16. In Colorado Revised Statutes, 24-37.5-103, add (5)

as follows:

24-37.5-103. Office of information technology - creation - information technology revolving fund - geographic information system coordination - repeal.

(5) (a) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (3)(c) OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER ELEVEN MILLION DOLLARS FROM THE INFORMATION TECHNOLOGY REVOLVING FUND TO THE GENERAL FUND.

(b) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (3)(c) OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2027, THE STATE TREASURER SHALL TRANSFER TWENTY MILLION DOLLARS FROM THE INFORMATION TECHNOLOGY REVOLVING FUND TO THE GENERAL FUND.

(c) THIS SUBSECTION (5) IS REPEALED, EFFECTIVE JULY 1, 2028.

SECTION 17. In Colorado Revised Statutes, 24-37.5-120, amend (7)(b); and add (7)(a.1) as follows:

24-37.5-120. Technology risk prevention and response fund - creation - definitions - repeal.

(7) (a.1) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER TEN MILLION DOLLARS FROM THE FUND TO THE GENERAL FUND.

(b) This subsection (7) is repealed, effective ~~July 1, 2026~~ JULY 1, 2027.

SECTION 18. In Colorado Revised Statutes, 24-38.5-120, add (4.5) as follows:

24-38.5-120. Decarbonization tax credits administration cash fund - definitions - repeal.

(4.5) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2027, THE STATE TREASURER SHALL TRANSFER THE UNEXPENDED AND UNENCUMBERED BALANCE OF THE FUND TO THE GENERAL

FUND.

SECTION 19. In Colorado Revised Statutes, 24-48.5-608, **amend** (2)(c)(II); and **add** (2)(c)(I.1) as follows:

24-48.5-608. Small business recovery and resiliency fund - repeal.

(2) (c) (I.1) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER FIFTEEN MILLION DOLLARS FROM THE SMALL BUSINESS RECOVERY AND RESILIENCY FUND TO THE GENERAL FUND.

(II) This subsection (2)(c) is repealed, effective ~~July 1, 2026~~ JULY 1, 2027.

SECTION 20. In Colorado Revised Statutes, 24-50-609, **amend** (5)(c)(II); and **add** (5)(c)(I.1) as follows:

24-50-609. State contributions - supplemental state contribution fund - creation - repeal.

(5) (c) (I.1) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (5)(a) OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER ONE MILLION DOLLARS FROM THE SUPPLEMENTAL STATE CONTRIBUTION FUND TO THE GENERAL FUND.

(II) This subsection (5)(c) is repealed, effective ~~July 1, 2026~~ JULY 1, 2027.

SECTION 21. In Colorado Revised Statutes, 24-75-232, **amend** (4)(c) as follows:

24-75-232. "Infrastructure Investment and Jobs Act" cash fund - creation - allowable uses - report - compliance monitoring - legislative declaration - definitions - repeal.

(4) (c) (I) ON JULY 1, 2026, THE STATE TREASURER SHALL TRANSFER FIFTEEN MILLION DOLLARS FROM THE FUND TO THE GENERAL FUND.

(II) On June 30, 2028, the state treasurer shall transfer all

unexpended money in the fund to the general fund.

SECTION 22. In Colorado Revised Statutes, 24-75-302.5, **add** (13) as follows:

24-75-302.5. Controlled maintenance - trust fund - legislative declaration.

(13) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER THE UNEXPENDED AND UNENCUMBERED BALANCE OF THE CONTROLLED MAINTENANCE TRUST FUND TO THE GENERAL FUND.

SECTION 23. In Colorado Revised Statutes, 24-75-1401, **amend** (2)(b)(III)(B); and **add** (2)(b)(III)(A.1) as follows:

24-75-1401. Indirect costs excess recovery fund - creation - departmental accounts - use of fund - definitions - repeal.

(2) (b) (III) (A.1) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER ONE MILLION DOLLARS FROM THE ACCOUNT FOR THE DEPARTMENT OF PUBLIC SAFETY WITHIN THE INDIRECT COSTS EXCESS RECOVERY FUND TO THE GENERAL FUND.

(B) This subsection (2)(b)(III) is repealed, effective ~~July 1, 2026~~ JULY 1, 2027.

SECTION 24. In Colorado Revised Statutes, 24-82-102.5, **add** (5)(e) as follows:

24-82-102.5. Unused state-owned real property - cash fund - legislative declaration - definitions - repeal.

(5) (e) (I) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER EIGHT HUNDRED THOUSAND DOLLARS FROM THE FUND TO THE GENERAL FUND.

(II) THIS SUBSECTION (5)(e) IS REPEALED, EFFECTIVE JULY 1, 2027.

SECTION 25. In Colorado Revised Statutes, 24-102-202.5, **amend**

(2)(c)(III)(B); and **add** (2)(c)(III)(A.1) as follows:

24-102-202.5. Supplier database - fees - cash fund - program account - repeal.

(2) (c) (III) (A.1) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER FIVE MILLION FOUR HUNDRED THOUSAND DOLLARS FROM THE SUPPLIER DATABASE CASH FUND TO THE GENERAL FUND.

(B) This subsection (2)(c)(III) is repealed, effective ~~July 1, 2026~~ JULY 1, 2027.

SECTION 26. In Colorado Revised Statutes, 25-3.5-307, **add** (2)(c) as follows:

(2) (c) (I) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (2)(b) OF THIS SECTION TO THE CONTRARY, ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER TWO HUNDRED FIFTEEN THOUSAND DOLLARS FROM THE FIXED-WING AND ROTARY-WING AMBULANCES CASH FUND TO THE GENERAL FUND.

(II) THIS SUBSECTION (2)(c) IS REPEALED, EFFECTIVE JULY 1, 2027.

SECTION 27. In Colorado Revised Statutes, 25-7-129, **amend** (4)(b); and **add** (4)(a.1) and (4)(a.3) as follows:

25-7-129. Disposition of fines - community impact cash fund - repeal.

(4) (a.1) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER FIVE MILLION ONE HUNDRED SIXTY-TWO THOUSAND THREE HUNDRED SEVENTY-THREE DOLLARS FROM THE FUND TO THE GENERAL FUND.

(a.3) ON JUNE 30, 2027, THE STATE TREASURER SHALL TRANSFER FIVE MILLION DOLLARS FROM THE FUND TO THE GENERAL FUND.

(b) This subsection (4) is repealed, effective ~~July 1, 2026~~ JULY 1,

2028.

SECTION 28. In Colorado Revised Statutes, 25-7-1405, **amend** (4)(c); and **add** (4)(b.1) as follows:

(4) (b.1) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (2)(a) OF THIS SECTION TO THE CONTRARY, ON JULY 1, 2026, THE STATE TREASURER SHALL TRANSFER AN AMOUNT EQUAL TO THE UNEXPENDED AND UNENCUMBERED BALANCE OF THE FUND MINUS SEVEN HUNDRED NINETY-NINE THOUSAND TWO HUNDRED DOLLARS FROM THE FUND TO THE GENERAL FUND.

(c) This subsection (4) is repealed, effective ~~July 1, 2026~~ JULY 1, 2027.

SECTION 29. In Colorado Revised Statutes, 25-8-902, **add** (7) as follows:

25-8-902. School and child care clean drinking water fund - creation - repeal.

(7) (a) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE CONTRARY, ON JUNE 28, 2026, THE STATE TREASURER SHALL TRANSFER FIVE MILLION THREE HUNDRED THOUSAND DOLLARS FROM THE FUND TO THE GENERAL FUND.

(b) THIS SUBSECTION (7) IS REPEALED, EFFECTIVE JULY 1, 2027.

SECTION 30. In Colorado Revised Statutes, 25-8-1006, **add** (4) as follows:

25-8-1006. Mobile home park water quality fund - repeal.

(4) (a) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER THREE MILLION DOLLARS FROM THE FUND TO THE GENERAL FUND.

(b) THIS SUBSECTION (4) IS REPEALED, EFFECTIVE JULY 1, 2027.

SECTION 31. In Colorado Revised Statutes, 39-3-211, **add (7)(e)** as follows:

39-3-211. Reporting of assessed value reductions - reimbursement of local governmental entities - local governmental entity backfill cash fund - creation - legislative declaration - definitions - repeal.

(7) (e) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE CONTRARY, ON JUNE 12, 2026, THE STATE TREASURER SHALL TRANSFER SIXTEEN THOUSAND SEVEN HUNDRED FORTY-SEVEN DOLLARS FROM THE FUND TO THE GENERAL FUND.

SECTION 32. In Colorado Revised Statutes, 39-29-109.3, **add (14)** and (15) as follows:

39-29-109.3. Severance tax operational fund - core reserve - grant program reserve - definitions - repeal.

(14) (a) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER SEVEN MILLION TWO HUNDRED FIFTY-TWO THOUSAND NINE HUNDRED NINETY-SIX DOLLARS FROM THE FUND TO THE GENERAL FUND.

(b) THIS SUBSECTION (14) IS REPEALED, EFFECTIVE JULY 1, 2027.

(15) (a) ON JUNE 30, 2027, THE STATE TREASURER SHALL TRANSFER ELEVEN MILLION ONE HUNDRED FIFTY THOUSAND DOLLARS FROM THE FUND TO THE GENERAL FUND.

(b) THIS SUBSECTION (15) IS REPEALED, EFFECTIVE JULY 1, 2028.

SECTION 33. In Colorado Revised Statutes, 39-29-110, **add (7)(g)** and (7)(h) as follows:

39-29-110. Local government severance tax fund - creation - administration - definitions - repeal.

(7) Notwithstanding any provision of this section to the contrary:

(g) ON JUNE 30, 2026, THE STATE TREASURER SHALL TRANSFER

NINETEEN MILLION FOUR HUNDRED THOUSAND DOLLARS FROM THE LOCAL GOVERNMENT SEVERANCE TAX FUND TO THE GENERAL FUND.

(h) ON JUNE 30, 2027, THE STATE TREASURER SHALL TRANSFER TWENTY-SEVEN MILLION THREE HUNDRED THOUSAND DOLLARS FROM THE LOCAL GOVERNMENT SEVERANCE TAX FUND TO THE GENERAL FUND.

SECTION 34. Safety clause. The general assembly finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, or safety or for appropriations for




