A BILL FOR AN ACT

CONCERNING CONTINUITY OF CARE FOR DISPROPORTIONATELY IMPACTED COMMUNITIES.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov.)

The bill requires the department of public health and environment and the department of health care policy and financing (health departments) to jointly issue advisory guidance to health-care providers and health-care facilities prohibited from receiving federal medicaid financing pursuant to the federal budget bill, H.R. 1 of the 119th Congress (2025-2026), on how to prioritize the continuity of care for

disproportionately impacted communities, with an emphasis on rural areas, communities of color, and low-income populations. The advisory guidance must include strategies, within the provider's scope of practice, for maintaining access to immunizations, cancer screenings, and family planning services for these communities.

1 *Be it enacted by the General Assembly of the State of Colorado:* 2 SECTION 1. Legislative declaration - legislative intent. 3 (1) The general assembly finds and declares that: 4 (a) Reductions or changes in federal health-care funding 5 associated with the federal budget bill, H.R. 1 of the 119th Congress 6 (2025-2026), Pub.L. 119-21, including the bill's ban on spending 7 medicaid dollars on services provided by essential community providers, 8 have the potential to disproportionately harm disproportionately impacted 9 communities; 10 (b) These impacts may result in loss of coverage, reduced access 11 to care, worsened health outcomes, and a strain on community health 12 systems; and 13 (c) The state of Colorado must safeguard disproportionately 14 impacted communities. 15 (2) It is the intent of the general assembly that the department of 16 public health and environment and the department of health care policy 17 and financing carry out the requirements of this act through the use of 18 existing resources. 19 **SECTION 2.** In Colorado Revised Statutes, add 25-1-139 as 20 follows: 21 25-1-139. Continuity of care advisory guidance - repeal. 22 (1) By December 15, 2025, the department of public health and 23 ENVIRONMENT, CREATED IN SECTION 25-1-102, AND THE DEPARTMENT OF

SECTION 3. Safety clause. The general assembly finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, or safety or for appropriations for the support and maintenance of the departments of the state and state institutions.
